The Alta Loma School District has a vacancy on its Governing Board. The Board has determined to provisionally appoint a replacement Trustee in Trustee Area 5 to serve until the end of the retiring member's current term. The Board desires to receive applications from community members who not only meet the minimum legal qualifications, but who support the mission of the Alta Loma School District. The Board seeks a Trustee to serve for at least the remainder of the term, which will conclude in December, 2022, and who will commit to the time and effort to provide a quality education for the students of the District. The Board may place an emphasis on candidates from Trustee Area 5. For the November 2022 election, candidates will be required to be a resident of Trustee Area 5 to run for this vacant seat.

REQUIRED QUALIFICATIONS OF GOVERNING BOARD MEMBERS (Pursuant to Education Code section 35107)

- Candidates must be 18 years of age or older.
- Candidates must be U.S. Citizens.
- Candidates must be registered voters.
- Candidates must reside within the Alta Loma School District.
- Candidates cannot be disqualified by the Constitution or laws of the State from holding a civil office.
 - AB 2410 makes a person ineligible for state or local elective office if they have, "been convicted of a felony involving accepting or giving, or offering to give, any bribe, the embezzlement of public money, extortion or theft of public money, perjury, or conspiracy to commit any of those crimes."
- Employees of the District are eligible to serve on the Board; however, prior to taking office, the employee must resign from District employment.
