SUPERINTENDENT & STAFF REPORTS

Beautiful, joyous, hopeful, amazing, exciting, were just a few of the words Lisabeth Piña shared with the Board that she heard this morning from both teachers, administrators and parents alike. This morning Alta Loma School District was able to welcome back some of our Special Education students to campuses. As soon as we were given guidance on how to bring back and serve students with disabilities in small cohorts, we started working on it. The first planning began September 4; we polled parents, determined teacher preferences and started to develop a small cohort plan. October 19th was the original date planned to bring students back, but we wanted to make sure everything was in place we pushed the date to today, November 4th. 82 students with special needs were able to come to school today. They all wore their mask, elbow bumped their friends, socially distanced in lines, played socially distanced recess games, and most of all they smiled. Lisabeth Piña highlighted the amazing job our school administrators, teachers, staff at each of the 5 sites and District staff did to prepare and welcome our students back.

Superintendent Moore congratulated Mr. Buller on his re-election; we are grateful for his service to our community. Mr. Moore thanked the Board for their hard work and putting their heart and soul in the selection and hiring of the new Superintendent for the school District.

Associate Superintendent Lori Thompson shared with the Board the recommendations from the San Bernardino County Superintendent of Schools on our Learning Continuity and Attendance Plan. A few recommendations asked for more detail on stakeholder meetings and curriculum, while other recommendations had to do with funding. Mrs. Thompson is working with our Fiscal Services Director, Eric Hart to find ways to address this and we will continue to have conversations with our Title 1 schools ensure we have increased services for them.
